

# DIPLOMA OF FRAUD CONTROL (PSP50716)



## ONLINE TRAINING & ASSESSMENT PROGRAM Flexible Commencement and Completion

The Diploma of Fraud Control (PSP50716) is prescribed by the Commonwealth Fraud Control Framework 2017 as the suitable qualification for fraud managers. This program has also been designed to align with requirements prescribed by Australian Standard 8001 - Fraud and Corruption Control.

Occupational fields include audit/financial control, employment investigations, regulatory compliance, risk management and corruption prevention.

### COMMONWEALTH FRAUD CONTROL FRAMEWORK 2017

55. ...officials engaged primarily in fraud control activities possess or attain relevant qualifications or training to effectively carry out their duties.

56. ...Relevant training can include ... a Diploma of Government (Fraud Control) or equivalent qualification for officials managing fraud control.

**SUITABILITY GUIDE:** This course is suitable for people where part of their current employment duties includes fraud detection, investigation or prevention. It would also be a suitable course for people with a background in law enforcement or people with formal qualifications in accounting, finance, law or government investigations. Other persons who believe they could successfully complete this course should contact the course coordinator to discuss suitability.

#### COURSE DELIVERY

Online training involves the supply of written learning materials supported by online video training sessions. Assessment is facilitated using an electronic workbook supported by online discussion-based tutorials together with ongoing access to assessment support by email.

- (2) Fraud Risk Assessment
- (3) Fraud and Corruption Control Plans
- (4) Implement Fraud Control
- (5) Public Sector Leadership
- (6) Research and Information Processes

**FLEXIBLE COMPLETION:** Training and assessment is delivered through sessions allowing flexible commencement and completion over a 12-month enrolment duration.

**FEE:** **\$2490** (GST-free). This is the full fee and no additional costs apply.



People who have previously completed the Diploma of Government Investigations with SIPS receive full credit for sessions 5-6 and partial assessment credit for sessions 2 and 4. Fees are reduced to \$1590.
