

# DIPLOMA OF GOVERNMENT INVESTIGATIONS (PSP50416)



Public Access Program | Sydney February-March 2020  
accelerated blended delivery – suitability guidelines apply

The Diploma of Government Investigations (PSP50416) is prescribed by the Australian Government Investigations Standards (AGIS) as the minimum qualification for people engaged to coordinate or supervise government investigations. Occupational fields include employment investigations, regulatory compliance, professional standards and fraud/corruption control.

It is usually delivered internally for groups of people from the same workplace and this program provides a pathway for people who do not have the opportunity to participate in a course delivered at their workplace.



**SUITABILITY GUIDE:** Currently employed to supervise government investigations; or have completed the Certificate IV in Government Investigations; or are nominated by their employer as being a person who could successfully complete this course. People not meeting the above description, who believe they could complete this course, should contact the course coordinator.

The program consists of 2 workshops however people who have previously completed the Certificate IV in Government Investigations are eligible for the **UPGRADE PROGRAM\*** and receive credit for workshop 1. Delivery dates and fees for the next Sydney program are:
