

# GOVERNMENT INVESTIGATION

## Melbourne Workshops – June & July 2018

➤ Certificate IV in Government Investigations – PSP40416

➤ Diploma of Government Investigations – PSP50416

This program is for people seeking to obtain the nationally recognised qualifications prescribed by the AGIS as the minimum level of training for government investigations staff. Occupational fields include:

- Employment misconduct investigations
- Regulatory inspection and enforcement
- Monitoring professional standards
- Fraud and corruption control



Both courses are accelerated and involve attending 2 x 2-day workshops and completing post-workshop projects. Enrolment in the **Certificate IV** qualification is open to current government employees or contractors who have access to a workplace where investigations are conducted. The **Diploma** course is open to people who have previously completed the **Certificate IV in Government Investigations** or who currently supervise or manage government investigations or investigators. Applicants who do not meet admission requirements, but believe they could successfully complete the course, should contact the course coordinator to discuss suitability.

### AUSTRALIAN GOVERNMENT INVESTIGATIONS STANDARDS 2011

#### 1.5 Investigator qualifications

The minimum level of training or qualification recommended for investigations staff are:

- Certificate IV in Government (Investigation), or its equivalent, as set out in the Public Services Training Package (PSP04). This qualification should be obtained before an officer is primarily engaged as an investigator; otherwise the officer should be under the supervision of a qualified investigator.
- Diploma of Government (Investigation), or equivalent, as set out in the Public Services Training Package (PSP04) for staff primarily engaged in the coordination and supervision of investigations.
